- * The Plan/Site Inspection Fee set forth above is for the initial review of construction documents submitted in support of an application for a construction permit, and where appropriate a site inspection. Additional reviews of re-submitted or revised plans and /or additional site inspections shall be calculated at the rate of \$55.00 an hour, with a minimum fee of \$55.00.
- * Residential Development Reviews – Fees will be based on the amount of fire hydrants located in a single family residential project. Fees will be \$100.00 per fire hydrant. NOTE: Fees for multi-family projects will be based on the total square footage using the above fee schedule
